- a. Town Levy Aguilar suggested lowering the tax rate, based on his numbers presented for the Town Levy. There will be no major changes other than the lowering of the rate. The board is happy to be able to provide some relief with the current rise in costs, as well as unknown changes to individuals in the Fire Protection District. <u>Schultz made a motion to approve the levy for the 20-day viewing period for public review. Anderson seconded the motion, with all voting in favor.</u>
- b. Road & Bridge Levy Lundahl felt that no raise is needed in the Road and Bridge Levy. He is pleased with the fact that no raise is needed at this time, due to the amount in reserve. Schultz confirmed that the price of salt has not skyrocketed. Lundahl told Schultz and the board that it has not. Lundahl showed a sheet with projected projects for the coming year. All expenses are up. Lundahl does not want to spend large amounts of money, with the current economic environment. Schultz made a motion to approve the 20-day viewing period for public review. Anderson seconded the motion, with all voting in favor.
