# SOUTH MOLINE TOWNSHIP BOARD OF TRUSTEES MEETING

## **September 5, 2023**

**MEETING CALLED TO ORDER** — Meeting was called to order at 5:30 p.m. by Supervisor Aguilar.

#### PLEDGE OF ALLEGIANCE

**APPROVAL OF MINUTES** — Motion by Schultz, second by Gripp, that we approve the minutes of August 21, 2023 with the correction of one sentence saying that a citizen's house value had <u>no</u> impact on the discussion. Motion carried, with all voting in favor.

#### **OFFICIALS' REPORTS —**

- **a.** Road Commissioner Lundahl stated that he would like to present a monthly report. Storage bins for salt have been completed. Cleaning up the facility has been a task.
- **b. Veterans** Burton presented images of flags purchased for the veterans' events. Certain stipulations are listed at the senior center to request services. A completed brochure will be sent out, and we will have flag decorating, and kits for building models. We are hoping to have a soft opening on September 15<sup>th</sup> at 5:30 and a grand opening on the 29<sup>th</sup> with the time yet to be decided. Shirts have been made and are for sale for \$25. A random drawing was held among the board members and Gripp won a tee-shirt.

Clarification and conversation started about money given to Burton. Aguilar explained the stipend. Future compensation for Burton will be discussed. Schultz asked who insurance falls under and about the liability situation for the ride-sharing program. He continued by stating that the township needs to be considered in these situations. Burton clarified some things and provided a few options. Further discussion is needed.

Further discussion is needed.
